## Gretchen Keyworth

Gretchen Keyworth, Fuller Craft Museum's Director Emeritus and Chief Curator, has led a long and lustrous career. Before becoming Director and Chief Curator of Fuller Craft Museum, she managed a consulting business helping to develop business and marketing plans for craft artists and organizations. Keyworth co-founded Signature Galleries and Grohe Glass Gallery, and has also served as director or advisor for several prominent craft shows, including Crafts at the Castle; Fine Furnishings, Providence; and CraftBoston. She also served as Director of Cultural Promotions for the City of Boston's Office of Cultural Affairs. Keyworth's relationship with the Fuller dates back to 1988, when she served on the museum's board of directors and collection committee.

South Shore Art Center invites entries that offer distinctive, imaginative imagery, using 2 or more media.

### ELIGIBILITY:

Open to all artists and all media. No geographical restrictions. Work must have been completed since January 1, 2007 and not previously shown at South Shore Art Center. All work must be for sale.

### SPECIFICATIONS:

Maximum size 60" any direction; two-dimensional work must be suitably framed and firmly wired. No sawtooth hangers, no sandwich frames.

### ENTRY PROCEDURE AND FEES:

Jpeg Digital Files: Up to five works may be submitted as jpegs. Image files should be 1200 pixels in the largest dimension, 300dpi. CDs & digital files should be clearly labeled/named starting with the artist's name, numbered corresponding to the entry form. (i.e...baker\_1Untitled) Please limit naming convention to no more than 30 characters. Submit files that can be read on both Mac and PC.

Statement: Must be in printed form. Please do not send electronic files for Artist resume & statements.

Fees: \$25 for up to 3 entries, \$35 for 4, \$45 for 5

### SALES: ALL WORK MUST BE FOR SALE.

South Shore Art Center receives 40% of the purchase price. No accepted entry may be withdrawn prior to the close of the exhibition. No pricing changes will be allowed after acceptance.

### LIABILITY:

South Shore Art Center will insure work accepted to the extent of 60% of the artist's stated value while the work is in the Art Center's custody and control. **AGREEMENT:** Submission to Media Mix constitutes an agreement with all conditions of this show. South Shore Art Center reserves the right to photograph an accepted work for publicity purposes. South Shore Art Center reserves the right to reject any work not resembling the submitted entry or work that is not ready to be shown according to the aforementioned specifications.

### DELIVERY AND RETURN OF ACCEPTED WORK:

Work may be hand delivered or shipped through the exhibition's shipping agent. For a handling fee of \$25, First Class Pack & Ship in Weymouth will receive artwork and deliver it to South Shore Art Center and at the end of the exhibition will pick up, package and return work to participating artists. Instructions will be sent to those artists whose work is accepted. Return shipping fees are an additional cost. **NO MORE THAN THREE PIECES PER \$25 FEE.** For more detailed instructions call:
